The site currently comprises a single-storey shop with hardstanding and has negligible existing biodiversity value. The proposed development to extend the building to two storeys to provide four residential flats will not result in the loss of any habitat or trees. To ensure a measurable biodiversity net gain, the scheme will incorporate wildlife-friendly measures including the installation of integrated bird and bat boxes within the new building. These enhancements will provide ecological opportunities for wildlife and will result in a clear biodiversity improvement compared with the current baseline. The proposal therefore complies with the requirements of the Environment Act 2021 and local planning policy on Biodiversity Net Gain.
