Existing brickwork cavity walls with full height window panels

Proposed materials and finishes:

The existing external brickwork to the ground floor walls will be chemical cleaned to remove the existing painted murals. While the external brickwork walls at first floor level will be externally cladded with a coloured insulated rain screen, which will also form the parapet above existing roof level, to create a guarding around the roof perimeter. There are two proposed staircase extensions, which will have external walls in red brickwork that will contrast with the existing walls and will also have contrasting features. See Drawing No. A1/2005021/BS/28B Proposed Elevations for details.

The main roof of the existing building has a flat built up felt covering on an insulated metal deck, which is to remain.

The roof to proposed Staircase 1 will have a mono-pitch roof with a Cambrian Slate finish, above the parapet level. The roof to proposed Staircase 2 will have an insulated flat roof with a built up felt finish, it won't be seen as the new brick cavity wall of the extension will form a parapet around the perimeter of the roof.
