The building is the former Conservatives Club, a former working men's club which provided recreation and education to working class men and their families. The club closed in 2012, 180-years after it first opened. Its most recent use was as the Kohinoor Banqueting Hall. Recent imagery shows the building to be in disrepair, with main windows boarded up, and the ground largely unkempt. The bowling green at the rear of the building, which formed part of the recreational offering at the Club, is significantly derelict and has been disused since the club closed in 2012.
