The site is within the defined urban area and the principle of the development is supported – bringing back a vacant and underutilised site into residential use. The design of the proposal needs further review based on a strong appraisal of the local character area, but generally a 2 –3 storey building in this location which fronts onto Long Street and wraps round onto King Street is supported. I have raised some amenity concerns with regards to overlooking and outlook but i am confident these matters can be overcome following some amendments to the design
